

BUGBEE CHILDREN'S CENTER, INC.  
FEE SCHEDULE (2008-2009)

All families are eligible for the three step sliding fee scale according to income verification and classroom placement by age of the child. Fees by income level and pertinent information are located on the other side of this form. Families of multiple children enrolled in the Center may be eligible for the Sibling discount.

**Available Discounts:**

- A discount is given to federal block grant eligible SUNY students (income eligibility guidelines and applications are available in the office).
- A 30% fee reduction is available for children of Bugbee Children's Center employees.
- A 10% sibling reduction is granted to all children, beyond the first child enrolled and applied to the lower fee.

**Enrollment Fees:**

- Application fee: A non-refundable fee of \$20 per child to be placed on the waiting list
- Registration fee: Upon enrollment a non-refundable payment of \$50 will be charged per **family**
- Deposit: A refundable deposit due for each enrolled **family**:
  - \$300 for full-time childcare
  - \$150 for part-time childcare
  - \$100 for subsidized care

**Childcare Fees:**

- Childcare Fees Are Rates Charged For Each Child According To Contracted Attendance And Room Placement.
  - ❖ State mandated ratios of staff to children are determined by age of the children.
  - ❖ Infant ratio - One Staff to Four Children
  - ❖ Toddler ratio - One Staff to Five Children
  - ❖ Preschool ratios - One Staff to Seven Children (3 year olds)
  - ❖ Preschool ratios - One Staff to Eight Children (4 year olds)
  - ❖ School Age ratios - One Staff to Ten Children (Under 10 years old)
  - ❖ School Age ratios - One Staff to Fifteen Children (Over 10 years old)
- A Full Week of care consists of four or five Full Days of child care.
- A Full Day of care is OVER 5 hours of contracted time according to the enrollment agreement.
- A Part Day of care is UNDER 5 hours and only available 7:30am-12:30pm  
Exception: Infant room 104 may access either a 7:30am-12:30pm or 12:30pm-5:30pm block of time

**Part Time Schedules/Extra Hours Care:**

If more hours of care are required beyond your part time contracted arrangement additional hours may be requested in advance. Please notify us twenty-four hours before the necessary time and we will work with you to accommodate your request. Additional hours of care are billed at a rate of \$7 per hour for each child accessing this service.

**Daycare Subsidy:**

The Department of Social Services Daycare Subsidy does not reimburse at our rates. Families receiving daycare subsidy are responsible for parent co-pay and any amount not eligible for reimbursement.

#### **School Age Program:**

The Center will provide care for scheduled school closings according to the Oneonta City School Calendar. The days of care include holidays, scheduled half day dismissals, vacation days and full day weather/emergency related closings. Scheduled Early Dismissal Days Are Charged As "A Half Day" of Care.

**RATES (School Age):** Half Day \$23 Full Day \$35

This sliding fee scale is applicable for the charging of tuitions and fees for the 2008 through 2009 fiscal year. The BUGBEE Children's Center, Inc. (Also referred to as SUCO Children's Center, Inc.) reserves the right to change fees at any time or child's classroom placement for the overall experience and growth of the child. A signed enrollment agreement is required for all families.
